### Job Description

The IT Application Support Specialist is responsible for providing technical support and troubleshooting for the organization's software applications. This role involves working closely with end-users, diagnosing and resolving application issues, and ensuring that applications are running smoothly and efficiently. The IT Application Support Specialist also collaborates with development teams and vendors to manage application updates, enhancements, and integrations

Application Support:

- Provide day-to-day technical support for software applications used by the organization
- · Troubleshoot and resolve application issues reported by end-users, ensuring minimal disruption to business operations
- · Document support requests and solutions in a ticketing system and ensure timely resolution SQL Query Development:
- · Design, develop, and optimize complex SQL queries to extract, manipulate, and report data from multiple databases
- Ensure that gueries are efficient, accurate, and optimized for performance
- · Collaborate with data analysts and other stakeholders to translate business requirements into technical solutions Reporting and Data Visualization:
- Develop, maintain, and enhance reporting solutions, including dashboards, static reports, and ad hoc queries
